### FIRST ATTEMPT SITTING PRIMARY EXAM – (MCQ & OSCE/SOE Components):

#### NORTH WEST & MERSEY DEANERY TRAINEES:

All Trainees must attend their own in-house Course at the first attempt of the Exam, and register as per their respective School website guidance. The Exam Practice Courses can only be attended if registered with the RCOA to sit the Exam the following month of the respective Course date.

### RESITTING PRIMARY FRCA MCQ EXAM:

#### NORTH WEST DEANERY TRAINEES:

Re-attendance to your in-house Exam Practice Course is permitted to the max 6 attempts allowed to take the Exam and registration is within your Primary FRCA Course fees taken in Year 1&2.

Attendance to the MSA MCQ Exam Practice Course is permitted but is out-with your Primary FRCA Course Fees, and all costs incurred are your responsibility. You will be given time but not study leave money. Departmental Leave must be secured via the normal Study leave process.

#### MERSEY DEANERY TRAINEES:

It is permitted to attend the North West Deanery Exam Practice Courses as detailed below and registration is essential to attend by completing the registration form located on the mmacc.uk website. Departmental Leave must be secured via the normal Study leave process. There is no charge to attend.

### RESITTING PRIMARY FRCA OSCE/SOE (or either component):

#### NORTH WEST DEANERY TRAINEES:

Re-attendance to your in-house Exam Practice Course is permitted to the max 6 attempts allowed to take the Exam and are within your Primary FRCA Course Fees taken in Year 1 & 2.
